

# *Redmond Rod & Gun Club*

## *2008 Annual Membership Meeting*

Date: December 7, 2008

Time: 2:00 pm sharp

Place: Powell Butte Community Center, 8404 SW Reif Road, Powell Butte, OR 97753

The purpose of the annual membership meeting is to elect Officers and Directors whose terms have expired, receive annual reports of Officers and committees and any other business which may properly come before the meeting.

Officer and Director Positions which are open for election are:

1. VP Rifle & Pistol
2. Three Director Positions (current directors: John Cameron, Bryan Piper, Bill Layton)

**Proposed Bylaw Changes.** The Bylaws committee and the Executive Board have recommended several proposed changes to the Bylaws. The changes need to be approved by a majority of the voting members at the Annual Membership meeting to become part of the Club Bylaws. A brief summary of changes follows.

1. Memberships. Reduce types of memberships from three to two; Annual and Honorary Life. Current types of Annual and Family are redundant.
2. Membership fees. Currently, membership fee changes must be approved by a majority of members at a membership meeting. Change to annual membership fees will be set by the Executive Board and reviewed once per year at the August Executive Board meeting. Memberships for the following year will be sold starting October 1<sup>st</sup>.
3. Membership meetings. Remove the current requirement for quarterly membership meetings.
4. Executive Board. Reduce the number of Directors from our current (8) to five. Added a new section to specify exactly when Executive Board members are elected.
5. Standing committees. Currently a member must have been a member of the Club for three years before they are eligible for office. Propose changing this to one year.

**2009 Membership Fees.** The Executive Board has proposed that Membership fees for 2009 be increased to \$50.00. This increase needs to be approved by a majority of the voting members at the Annual Membership meeting.

**Directions to PBCC.** From Prineville, go west toward Redmond on Hwy 126. Reif Road is the first major road past the Powell Butte store. Turn left (south) on Reif Road. Travel 1.5 miles. PBCC is on your left (only building out there).

From Redmond, travel east on Hwy 126 toward Prineville. Reif Road is the second road past the Powell Butte post office. Turn right (south) and follow directions above.

From Bend, travel north on the Powell Butte Highway. Approximately 1.5 miles before the junction of Powell Butte Hwy and Hwy 126, turn right (east) on Weigand Road. Travel one mile until Weigand terminates at Reif Road. Turn right and then left into the PBCC.

All members are highly encouraged to attend the membership meeting and support your Club.
